## **About Our Facility:**

- 1. Located at 1424 Cito Road, Big Cove Tannery, PA 17212
- 2. Vendor spaces are located indoors, and vendors will be located in the upstairs and the downstairs of the barn and at new shed at silo across Cito Road. Vendor spaces in the Morton, Shindig and Stonewall Rooms require a 2- day commitment (set up both Saturday and Sunday). Saturday only or Sunday only vendors will be assigned to the Loafing Barn or Shed at Silo across Cito Road. There are (2) restrooms on each floor.
  - \*\* If you have a reason for needing to set up outside (i.e. blacksmith), please email us at LisaD@needleinthehaystackllc.com to arrange.
- 3. Our facility is now fully handicap accessible.
- 4. One room of our facility has a low ceiling at 7' tall, with a railroad beam for support running through it to make the lowest point in the ceiling 6' tall. If you are accepted as a vendor and this is an issue for you, please let us know so we can accommodate you in one of the other rooms.
- <u>5.</u> There will be food stands and/or vendors on site providing options to purchase breakfast and lunch, as well as offer carry out meals.
- 6. Our facility is a barn, and only our downstairs rooms are heated/air conditioned. We do have fans to cool and patio heaters to heat depending on the weather, but please dress accordingly. Some vendors prefer to bring a rug or heavy mat to stand on in cold weather. Small portable buddy heaters are also permitted in some areas. Please get venue approval first.
- 7. Our facility is 100% secure and able to be locked.

## Terms and Conditions:

- Needle in the Haystack, LLC & Charlie's Art & Soul ("The Hosts") will allow (2 or 3) vendors selling
  the same type of product to set up at their vendor shows with the exception of jewelry and
  woodworking due to their variety. Only those goods specified in the Application shall be vended.
- All applications must be received via email to LisaD@needleinthehaystackllc.com. A confirmation email will be sent to you to confirm successful receipt of your application.
- The Hosts reserve the right to accept or reject each application.
- Applicants will be notified via email within (1) week after their application has filed on whether they have been accepted/rejected as a vendor. If the event is full, we will start a waiting list.
- Vendor spaces are limited. This event will allow approximately 55 vendors. Vendors with handmade, custom or unique items will be given first priority when accepting applications. More spaces may possibly be added at the discretion of The Hosts.
- Vendor spaces are 10 ft by 10 ft at a fee of \$35/space. Spaces will be taped out on the floor.
  - O Due to space constraints, we will be limiting each vendor to the purchase of (2) spaces.
